Employee Stock Options Variations

• Employee Stock Option Plan (ESOP)

Under ESOP an entity grants an option to its 'eligible employees' to acquire its shares at a future date but at a predetermined price.

• Employee Share Purchase Plan (ESPP)

A listed entity offers a right to acquire its shares instantly

Stock Appreciation Rights Plan (SAR)

- No such shares will be offered to its employee but he is given the appreciation in the value of shares between two specified dates as an incentive
- It is totally linked with the entity's performance as a whole

ESOP companies are 25% more likely to stay in Business.



Employee Stock Options Variations


Restricted Stock award

An offer subject to certain conditions such as the employer has the right to cancel the entitlement if the conditions are not met.

• Sweat equity


Shares issued to its key directors and/or employees at a discount or for a consideration other than cash for providing know how or rights in the nature of intellectual property, etc

Employee Stock Options Flow Chart

An Entity or Employer 'offers' to buy a certain number of stocks at a pre-determined price

An Employee can exercise the offer only if he is willing to be part of the entity for a defined period provided in ESOP agreement

Exercise Price may be either prevailing market price or less than the market price

Employer can offer them directly to the employees or through a 'Trust'


ESOPs will be taxed at two stages. First when an employee exercises his rights i.e., difference between the exercise price and prevailing market price

Secondly, at the time of selling them, the profit, if any, will be considered as either LTCG or STCG taxed accordingly



Employee Stock Options Issuing Company Concerns

- Achieving company objective (employee retention, performance /appraisal) vis-à-vis overall cost/compensation scheme.
- Determination of qualifying employee conditions as well as time line for grant of options, exercise price, vesting period, exercise period amongst others.
- Quantification of number of options to be granted keeping in view the strategic ownership of the company.





- Compliance with the laws Company law, Income Tax laws, SEBI guidelines, RBI guidelines, Insider Trading regulations.
- Drafting and maintaining proper scheme documentation
 Agreement, Scheme, FAQ, Grant letters, employee
